

# MANUFACTURER CERTIFICATION STATEMENT

## FEDERAL TAX CREDIT FOR RESIDENTIAL ENERGY EFFICIENT PROPERTY

### Federal Tax Credit as a Percentage of the Qualifying Solar Panel, Rechargeable Battery Pack, and Installation Cost:

- 30% on eligible products installed between 1/1/17 – 12/31/19
- 26% on eligible products installed between 1/1/20 – 12/31/22
- 22% on eligible products installed between 1/1/23 – 12/31/23

Details: Existing homes and new construction qualify. Both principal residences and second homes qualify. Rentals do not qualify. Taxpayers should retain this Manufacturer Certification for their records.
